a. Promotional Waiver Description

Effective October 22, 2009, the following promotions will be available:

- **Calling Feature Nonrecurring:** Customers who subscribe to any calling services feature, including the Caller ID Plus, will have the applicable nonrecurring charges waived for installation of the service.
- **Additional Line:** Business Customers who order an additional line at the same premise will have the applicable nonrecurring charges waived.
- **WINBACK:** The Company will waive the applicable nonrecurring charges for each access line or trunk ordered by residential and business customers who previously established service with another Local Exchange Carrier and who now wish to return to CenturyTel for Local Service.
- **Second Line \$9.95 bundle:** Available to residential customers with at least one residential one-party access line. The offering includes an additional residential one-party access line with Call Waiting. Customers who order this bundle may not be required to pay non-recurring Service Charges.

The line will be toll and outbound local call blocked, but will allow outgoing E911 and 711 abbreviated dialing along with unlimited inbound calls. This line does not include a directory listing. All applicable nonrecurring charges will be waived.
